3 Costs not included in this list of fees

The following expenses are not included in the certification costs and have to be paid separately:

- expenses necessary for the correct performance of inspection and surveillance. If it is necessary to use the car, a kilometer refund rate is applied equal to 0,40 Euro/km

4 TERMS OF PAYMENT

Within February 28th of each year

- Annual flat rate
- Cosmos annual fees
- Any pending amounts (e.g. document verification, inspection refund, tests, updated certificate, etc.)

Within June 30th of each year

- ICEA annual variable rate (calculation based on the previous year turnover)
- Any pending amounts (e.g. document verification, inspection refund, tests, updated certificate etc.)

Within November 30th of each year

- Any pending amounts (e.g. document verification, inspection refund, tests, updated certificate etc.)

THE EMISSION AND VALIDITY OF THE CERTIFICATE IS GRANTED ONLY IN CASE ALL INDICATED PAYMENTS HAVE BEEN ACCOMPLISHED. IN CASE THE COMPANY DOES NOT PAY WHAT IS DUE TO ICEA THE VALIDITY OF CERTIFICATE WILL BE SUSPENDED

The first year, the fixed annual rate (compared to the number of days from the date of submission of the request for services up to December 31st of the same year), documental evaluation and audit will be invoiced after the presentation of the List of fees, Application form and Informative Questionnaire.

If within April 30, the turnover subject to the ICEA variable rate is not communicated, a fixed amount of 10.000,00 € (ten thousand/00) will be demanded.

In case of withdrawal, the Operator shall have to pay:

- ICEA variable rate based on the last sales statement
- Cosmos annual fees based on the date of withdrawal
- Fixed annual rate, compared on the period of the contract of the current year;
- Any activities (eg. Documental evaluation, audits, etc.)
