

## Tariff for the approval of Cosmos cosmetic raw materials/ingredients

This list of tariffs concerns the approval of non-organic cosmetic ingredients (NOI - Not Organic Ingredients) used in certified cosmetic products certified according to COSMOS procedure.

All the above-reported tariffs are to be intended net of VAT.

### 1 Tariffs for the issuance of the Attestation of Conformity

Table 1 indicates the tariff for evaluation and issuance of the Attestation of Conformity according to the requirements defined by COSMOS-standard Aisbl.

**Table 1 – Tariffs for approval**

<b>A</b>	<b>Ingredients'evaluation</b>	<b>€ 30/raw material or ingredient</b>
<b>B</b>	<b>Issuance of the Attestation of Conformity*</b>	<b>€ 300</b>
<b>C</b>	<b>Updating and new attestation issuance</b>	<b>€ 100</b>

*\*The sum for the "Issuance of the Attestation of Conformity" - Table 1, letter b) – is according to the number of days since the submission of the request for approval until December 31st of the current year for a minimum amount of 200 €.*

*The Attestation of Conformity has a validity of 3 years since the date of issue. At the end of the 3 years the authorization shall be renewed by applying the tariff reported in point 3 of this list of tariffs.*

### 2 Discounts

The following table reports the discounts considered according to the number of products for which the evaluation is required (table1).

**Table 2 – Discounts**

<b>Number of products to evaluate</b>	<b>Evaluation cost (by ingredient)</b>
≤50	€ 30
>50 and ≤100	€ 25
≥100	€ 20

### 3 Tariffs to maintain the Attestation of Conformity

To maintain the Certificate of Conformity the following annual tariffs are applied

**Table 3 – Annual tariffs to maintain the Attestation of conformity**

<b>A</b>	<b>FIX RATE (first 10 ingredients)</b>	<b>€ 300</b>
<b>B</b>	<b>VARIABLE RATE (exclusively applied to the products after a number of ten)</b>	<b>€ 25/raw material or ingredient</b>

#### 4 Deadlines and method of payment

##### ***At the submission of the application***

- Ingredients evaluation
- Attestation of Conformity Issuance
- Updating Attestation

##### **By February 28th**

- Fix and variable rate

The payments must be made to ICEA - Institute for Ethical and Environmental Certification - Via G. Brugnoli 15 - Bologna, by bank transfer.

#### 5 COSMOS annual fees

Cosmos annual fees (including annual registration and licence) equal to € 6 / ingredient, are already included in the above rates and will be paid annually by ICEA to COSMOS Aisbl, Rue du Commerce 124 Brussels.
